OVERVIEW INFORMATION-
Calculated from grants listings; totals sometimes different than "Program service" above (See "Fiscal information.") E/G Ratio shows expenses as a percentage of grants (program service) amount.

GRANTS BY CATEGORY-
Grant listings are organized by category, with average grant size per category and subtotals by percent and dollars within categories.

FUNDED PRIOR EDITION-
Bullets (•) next to grantee listings show grantees which received a grant from the profiled foundation in prior editions of the DataBook.

CAPITAL GRANT-
Capital grants are indicated with a (✳) symbol and there is an index of the foundations which made capital grants in the rear of the DataBook.

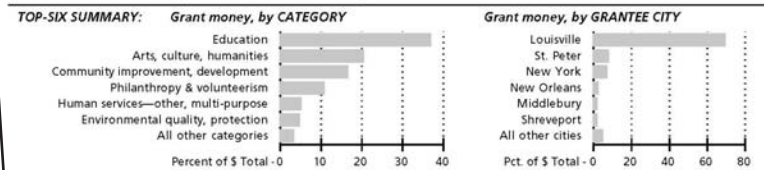
EVERY GRANT -

Purpose: The Humana Foundation supports organizations that improve the quality of life in communities where Humana has a meaningful presence. The Humana Foundation identifies, funds, and nurtures projects and organizations in three fields: domestic and international health, education, and civic and cultural development in communities where the company has a meaningful presence.
Restrictions: Organizations must be nonprofit and classified 501(c)(3) tax-exempt by the Internal Revenue Service. Individuals and private foundations are not eligible to receive funds. Most grants are given for one year; multi-year grants are given on an occasional basis. Normally, only one grant is made to an organization in a calendar year. Grants are not given to organizations for seed money. The Humana Foundation should not be the only funding source for an organization. An organization's base of community support should be as broad as possible. The Humana Foundation does not contribute to social, labor, political, veterans, or fraternal organizations. Religious organizations are eligible for project-specific support (e.g. social services outreach) or funds for an accredited, church-affiliated educational institution; however, the Foundation will not consider requests for general operating support, funding for the construction or renovation of a sanctuary, or mission-focused work. Institutions receiving payments for eligible religious projects must have 501(c)(3) status. Humana Foundation funds cannot be used solely to support an organization's salary expenses or other administrative costs. The Humana Foundation does not support lobbying efforts, political action committees, or any politically sensitive causes.
Geographic Focus: There are no geographical restrictions.
Deadlines: None. Proposals are reviewed from January 1st through October 15th in Louisville and until November 15th in other markets (see web site for list).
Published Info: Other info: Applications for contributions other than scholarships should be submitted by letter and accompanied by a copy of the organization's exemption letter under Code Section 501(c)(3). The application must request a specific dollar amount and include a brief explanation of the charitable activities of the organization. Charts show top categories for the grant money awarded by each foundation. After showing the top six categories (by percentage of dollars awarded), the display lumps all other grants together as "All other categories." Unique geographic charting of grant money by city gives a useful and clear picture of where the money goes.
